What happens if an adult or child becomes unwell whilst at school?

Staff have been informed of the symptoms of a possible coronavirus infection and will be kept up to date with national guidance about the these symptoms. If anyone in an education or childcare setting becomes unwell with a new, continuous cough or a high temperature, or has a loss of, or change in, their normal sense of taste of smell (anosmia), the situation will be referred to Wendy Turner or Kerry Devane and will be sent home and parents advised to follow the Government guidance :-

If a child is awaiting collection, they will be moved to a room where they can be isolated behind a closed door (Calm Room) and appropriate adult supervision will be provided by an adult from the child's safety bubble. Ideally, a window should be opened for ventilation. Staff member to wear PPE as a distance of 2 metres cannot be maintained for young children. If the child's' symptoms worsen the staff member will immediately call for help.

If a member of staff has helped someone with symptoms, they do not need to go home unless they develop symptoms themselves. They should wash their hands thoroughly for 20 seconds after any contact with someone who is unwell. Cleaning the affected area with agreed products that have been provided and are in line with COSHH requirements after someone with symptoms has left, will reduce the risk of passing the infection on to other people.

What happens if someone a member of staff becomes unwell whilst at school?

If a member of staff displays signs of being unwell they will immediately refer themselves to Wendy Turner or Kerry Devane and will be sent home and advised to follow [COVID-19: guidance for households with possible coronavirus \(COVID-19\) infection guidance](#)

What happens if there is a confirmed case of coronavirus (COVID-19) in school?

When a child, young person or staff member develops symptoms compatible with coronavirus (COVID-19), they should be sent home and advised to self-isolate for 7 days and arrange to have a test to see if they have COVID-19. They can do this by visiting [NHS.UK](#) to arrange or contact NHS 119 via telephone if they do not have internet access. Their fellow household members should self-isolate for 14 days. All staff and students who are attending an education or childcare setting will have access to a test if they display symptoms of coronavirus (COVID-19), and are encouraged to get tested in this scenario.

Where the child, young person or staff member tests negative, they can return to their setting and the fellow household members can end their self-isolation.

Where the child, young person or staff member tests positive, the rest of their class or group within their childcare or education setting will be sent home and advised to self-isolate for 14 days. The other household members of that wider class or group, do not need to self-isolate unless the child, young person or staff member they live with in that group, subsequently develops symptoms.

Advice will be sought from Public Health England's local health protection teams after they have conducted a rapid investigation to establish actions to be taken. In some cases, a larger number of other children, young people may be asked to self-isolate at home as a precautionary measure—perhaps the whole class, site or year group. Where settings are observing guidance on infection prevention and control, which will reduce risk of transmission, closure of the whole setting will not generally be necessary.
